## **Personal data processed by us**

A&E Translations processes your personal data because you make use of our services. Among the personal data we process are your given name and surname, gender, address details, phone number and email address. We also process the personal data contained in the documents to be translated (for example, in financial, medical or legal documents, extracts from official bodies, identity documents, deeds and contracts).

## **Why we process personal data**

A&E Translations processes your personal data for the following purposes:

- To be able to phone or email you in the performance of our services.
- To enable you to request a price quotation via our website.
- To deliver translations to you.
- For handling your payment.
- To be able to translate the contents of personal documents.

## **How long we keep your personal data**

Your personal data, which are stored in address files and in certified, legally valid (sworn) translations, will be kept by us as long as these files and documents may again have to be used by you in the future. The personal data will be deleted immediately when you notify us that you no longer wish us to be keep them.

## **Sharing personal data with third parties**

A&E Translations only provides data to third parties if this is necessary for carrying out our agreement with you, or for complying with a statutory requirement. Your confidential data will not be shared with any unauthorized third parties and the translation work will not be outsourced to third parties without your express permission. Nor will your data be used without your express permission for marketing purposes, such as in a portfolio.

## **Use of cookies**

On the website of A&E Translations ([www.vertaalbureau.biz](http://www.vertaalbureau.biz)), analytical cookies are used (by Google Analytics). You can deregister regarding the use of cookies by adjusting the settings of your internet browser in such a way that it no longer stores cookies. Moreover, you can delete previously stored cookies by using the settings of your browser.

## **Review, correction or deletion of personal data**

You have the right to review, correct or delete your personal data. You are also entitled to the transfer of data. This means that you may request us to send your personal data, which we keep in a computer file, to you or somebody else.

## **How we protect your personal data**

A&E Translations takes appropriate measures to prevent abuse, loss, unauthorized access, unwanted publication and illegal modification regarding your personal data.
